Players will be selected against England Netball Performance Pathway criteria and it is recommended that teachers and coaches nominating girls for these trials view the Trained Identifier resource. N.B. Players already in County Academy must not attend these trials.

Successful preliminary triallists will have further trials in May & June, along with current County Academy athletes prior to acceptance into the County Academy. The Academy will run between September and March in Uxbridge and North London. Athletes will receive enhanced coaching and skill development.
